

CLEBC Online Subscriber Agreement and Terms of Use

This Agreement is between the Continuing Legal Education Society of British Columbia (“CLEBC”) and the subscriber to CLEBC Online subscription products (the “Subscriber”). By using CLEBC Online subscription products, the Subscriber agrees to be bound by the terms of this Agreement.

Definitions

1. CLEBC Online subscription products include:
 - a. Courses on Demand
 - b. Online Course Materials
 - c. Online Practice Manuals
 - d. CLE Precedent Collection
 - e. Case Digest Connection
 - f. Advocacy Toolkit

(“CLEBC Online Subscription Products”).

2. “CLEBC Online Subscription” means access to any or all of the CLEBC Online Subscription Products.
3. “Law firm” means a legal entity or combination of legal entities carrying on the practice of law that is required to register with Law Society of BC or their respective jurisdiction. Individuals carrying the practice of law as sole practitioners are considered law firms.
4. “Subscriber” means a law firm or other organization that has a CLEBC Online Subscription.
5. “Authorized User” means employees of the Subscriber who have access to CLEBC Online Subscriptions.

Subscription Price and Payment

6. The Subscriber is purchasing a CLEBC Online Subscription. The price is based on the number of lawyers in the Subscriber’s law firm and the CLEBC Online Subscription selected. For organizations that are not law firms, the price is based on the number of lawyers plus non-lawyer users in the Subscriber’s organization.
7. The Subscriber represents that the number of lawyers in the firm or users in the organization that the Subscriber provides to CLEBC at initial purchase and at each renewal period of a CLEBC Online Subscription is accurate. The Subscriber must inform CLEBC promptly in writing of any changes to the Subscriber’s address.
8. CLEBC Online Subscriptions are for one-year terms and the Subscriber must commit to subscribing for a full year. The Subscriber may choose to pay for a CLEBC Online Subscription either monthly or annually. To pay monthly, the Subscriber must provide CLEBC with a credit card number and promptly notify CLEBC of any changes to the credit card.

9. All amounts due and owing to the CLEBC but not paid by the Subscriber on the due date will bear interest at the rate of 12% per year. Such interest will accrue from time to time on the balance of unpaid amounts outstanding from the date on which portions of such amounts become due and owing until payment is made in full.

Copyright

10. CLEBC Online Subscriptions contain proprietary, copyrighted information, documentation, computer code, and other materials (the "Product"). As between CLEBC and the Subscriber, CLEBC retains title to and ownership of all rights in and to the Product, including copyright and all other intellectual property rights.

Licence and Permitted Use

11. Any Authorized User may use or access the Product on any computer or device within the Subscriber's organization. The Product may be made available on a computer network within the organization, including an intranet to which only the organization's employees have access. Authorized Users must not disclose the organization's user name and password to anyone outside the organization and must cease accessing CLEBC Online Subscriptions under the organization's user name and password when employment in the organization ceases. The Subscriber must communicate these obligations to employees.
12. In exchange for payment of applicable subscription fees, CLEBC grants the Subscriber a non-exclusive, non-transferable licence to access, retrieve, and view the Product while the Subscriber's CLEBC Online Subscriptions are in force for the purposes of law practice or legal study. This licence includes the right to:
 - a. print out, copy, download, or distribute in electronic or print form reasonable portions of the Product for the Subscriber's internal use;
 - b. download and adapt selected sections of the Forms, Precedents, Checklists, and Jury Instructions for use in client matters;
 - c. quote and excerpt from the Product, provided that CLEBC authorship and copyright notices are clearly marked, in work product created in the regular course of law practice and legal research.
13. This licence does **not** include the right to:
 - a. publish or post the Product or any portions of it on an internet site accessible by parties outside the Subscriber's organization;
 - b. copy, distribute, or make available the Product or any portions of it to parties outside the Subscriber's organization;
 - c. reproduce, publish, sell, rent, loan, lease, sub-licence, transfer, market, distribute, redistribute, or otherwise part with the Product or portions of it, in electronic or print form, except as permitted in this licence;
 - d. decompile, reverse engineer, or disassemble the Product, or create any derivative works based on the Product; or
 - e. make available any username or password associated with use of the Product to parties outside of the Subscriber's organization.

Termination

14. CLEBC reserves the right to terminate this Agreement immediately if the Subscriber breaches any terms of this Agreement, including but not limited to failure to make timely payments, misuse of the Product, or disclosure of passwords outside the Subscriber's organization. The Subscriber will remain obligated to pay for the complete subscription without any refund by CLEBC, and for any outstanding debts incurred regarding the use of the Product.

Disclaimer of Warranties

15. The Product is provided by CLEBC "as is" and is without representations, warranties or conditions of any kind. The Subscriber assumes total responsibility for the selection of the Product to achieve whatever the intended results may be, and for the use of the Product. CLEBC DISCLAIMS AND THE SUBSCRIBER WAIVES ALL REPRESENTATIONS, WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED OR STATUTORY, INCLUDING THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY, MERCHANTABILITY, DURABILITY, TITLE, NON-INFRINGEMENT AND FITNESS FOR A PARTICULAR PURPOSE. CLEBC DOES NOT REPRESENT OR WARRANT THAT ACCESS TO THE PRODUCT WILL BE UNINTERRUPTED OR ERROR-FREE. WHILE CLEBC ATTEMPTS TO ENSURE THAT ONLINE ACCESS AND USE OF THE PRODUCT IS SAFE, CLEBC CANNOT AND DOES NOT REPRESENT OR WARRANT THAT ITS COMPUTER SYSTEMS OR ITS SERVER(S) ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS.
16. CLEBC does not represent or warrant that the information contained in the Product will meet the Subscriber's needs. CLEBC does not represent or warrant that the contents of the Product are identical to the original material from which the Product was derived. CLEBC makes no representations, warranties or conditions with respect to any data gathered or obtained by CLEBC from any source, or for present or future methodology used by CLEBC in producing or obtaining such data. The Product does not and cannot replace the need for professional judgment as to the legal sufficiency and legal accuracy of any material contained in the Product. CLEBC offers the Product as an aid to developing and maintaining professional competence. The Subscriber acknowledges that the Product does not constitute legal or other professional advice. Law is constantly evolving and changes in practice and procedure occur frequently. The Subscriber must exercise professional judgment about the correctness or applicability of the material in the Product and refer to the relevant legislation, case law, administrative guidelines and other primary sources. Any precedents contained in the Product must be used only as an initial reference point, and are not to be relied upon to the exclusion of other resources or without carefully considering their applicability to the relevant matter. The views and conclusions of authors expressed in the Product are those of the authors and not necessarily those of CLEBC.

Limitation of Liability

17. **CLEBC WILL NOT BE LIABLE FOR INDIRECT, CONSEQUENTIAL, OR SPECIAL DAMAGES THAT RESULT FROM THE USE OF OR INABILITY TO USE THE PRODUCT.** CLEBC is not responsible for any costs incurred as a

result of the use of or inability to use the Product, including lost profits or revenue, loss of data, or failure to realize expected savings. In no event shall CLEBC's total liability to the Subscriber for all damages, losses, and causes of action (whether in contract, tort (including negligence), or otherwise) arising from or relating to the Product exceed direct damages in an amount equivalent to the amount paid by the Subscriber for the Product.

Indemnity

18. The Subscriber agrees to indemnify and hold CLEBC harmless from and against any loss, cost, expense or damage arising out of any claim, suit, action or judgment brought against CLEBC by any client of the Subscriber or any other person or entity arising from the Subscriber's use of the Product.

Controlling Law and Severability

19. This Agreement will be governed by and construed in accordance with the laws of the province of British Columbia and the federal laws of Canada applicable therein without regard to conflicts of law. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be unenforceable, that provision will be enforced to the maximum extent permissible so as to effect the intent of the parties, and the remainder of this Agreement will remain in full force and effect.

Entire Agreement

20. This Agreement represents the entire agreement between the Subscriber and CLEBC with respect to the Product, and supersedes all prior or contemporaneous understandings or agreements, written or oral, regarding the Product.

Changes

21. CLEBC reserves the right to change this Agreement. Any changes will be effective upon posting (electronic or otherwise) of a revised Agreement.
